

Anne and Scott Moore Educational Scholarship

Simon Kenton Council

The Scott and Anne Moore Scholarship is awarded annually to Eagle scouts, with demonstrated financial need, to help defray the cost of their post high school education. Applicants must graduate or have graduated from high school. The award is \$1,000 annually and may only be used to cover tuition, and course related expenses such as fees, books and equipment, to attend either a four year university or college, or a two year technical or vocational school. Applicants must earn the Eagle Scout rank within two years of the year the scholarship is awarded, and must be used within two years of the award. Applicants must be or plan to be a full time student. The NESA Committee of the Simon Kenton Council, and staff of the Simon Kenton Council shall administer the award. Applicants may reapply for each year they are enrolled in a two or four year academic program, provided the applicant maintains a 3.0 grade point or B average for the prior grading periods. Deadline for application is July 1st 2020.

Scholarship Qualifications and Fact Sheet

1. Attain the rank of Eagle, are less than 21 years of age, and use the award within two years receipt.
2. Must have graduated or plan to graduate from high school.
3. Must be, or plan to be, a full time student.
4. At the time of first application, be a registered member of the Simon Kenton Council.
5. The scholarship award is \$1,000.
6. While the scholarship is needs based, academic, scouting, community and religious involvement and activities are important and considered.
7. Attend a four year college or university, or a two year technical or vocational school.
8. Submit a completed application to NESA Committee c/o Simon Kenton Council on or before July 1st each year.
9. An application can be submitted every year the applicant is attending provided the applicant maintains a 3.0 grade point or B average for the proceeding grading periods.
10. The award is to be used only for tuition, and course related expenses such as fees, books, and equipment.
11. The award check will be sent to the recipient and will be made payable to the school, college or technical or vocational school.
