INDEPENDENT REGIONAL VOLUNTEER ASSESSMENT

- SKC Camps Operate at a \$800,000 Loss
- Over 43 BSA Camps within 3-hour drive
- SKC Camp Facilities Score Low in NCAP Selfevaluation – confirmed by Assessment team
- Brand Image Problem
- Poor BSA Representation
- 50%+ SKC Troops Camp Out of Council









RESULTING RECOMMENDATIONS

- Review Conservation easement at Camp Lazarus with the intent to sell all/part of property and invest proceeds in remaining properties
- Create council camp master plans for improving and developing remaining properties
- Initiate a capital campaign to address critical needs in remaining camps
- Develop business plan for remaining properties that moves camping operation to a sustainable level.

CONCLUSIONS & RESOLUTIONS

- Camp Property Stewardship Committee analysis of camp attendance and fiscal performance
- Early stages of camp master planning starting
- Camp Lazarus easement research conducted difficult to reverse
- "Business as usual" not sustainable
- Committee recommendations to SKC Executive Board





RECOMMENDATIONS TO SKC BOARD

Recommendation 1:

On or before September 1, 2020, close Chief Logan Reservation and cease all SKC operations at Chief Logan Reservation. Immediately publicly advertise and list for sale, lease, license, or other transaction, any or all portions of, or interests in, Chief Logan Reservation. Upon agreement, the Scout Executive, President and Treasurer are hereby authorized to encumber and expend all funds as may be reasonably necessary up to Fifty Thousand Dollars (US\$50,000.00) to prepare Chief Logan Reservation for listing and sale, lease, license, or other transaction Any resulting sale, lease, license, or other transaction of Chief Logan Reservation (or any portion or interest thereof) will be presented to the Executive Board for final approval prior to any such action becoming final.





RECOMMENDATIONS TO SKC BOARD

Recommendation 2:

Appoint a committee to immediately investigate revenue generating options, including but not limited to the sale, lease, license or other transaction, of land on the south and southeast portion of Camp Lazarus not currently encumbered by the existing conservation easement and otherwise not currently being regularly used in a material manner by SKC or its invitees or licensees. Upon agreement, the Scout Executive, President and Treasurer are hereby authorized to encumber and expend all funds as may be reasonably necessary to assist the committee in its investigation up to Twenty-Five Thousand Dollars (US\$25,000.00). Any resulting sale, lease, license, or other transaction of Camp Lazarus (or any portion or interest thereof) will be presented to the Executive Board for final approval prior to any such action becoming final.

- Create camp master plans that incorporate geographic and programmatic strengths of each SKC property
- Invest to improve properties and expand programs
- Create destination camps that grow toward fiscal sustainability and responsibility
