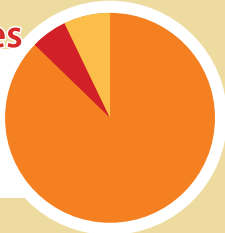

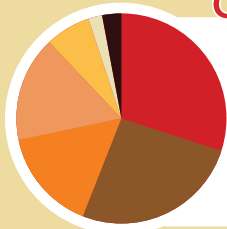
Council Expenses
