With the successful launch of new all-girl Troops into Scouts BSA, 2019 was a year of rewarding transition in Simon Kenton Council. Nationally over the last two years, this transition was met with a wide variety of opinions and judgement. Our society, so frequently confronted by the uncertainties of change and its debate, will soon recognize Scouting remains true to its mission. There was no retreat from more than 100 years of Scouting tradition moving forward without compromise, on the foundation of timeless values, serving our daughters as well as our sons, and the whole Scouting family.

In 2019, we welcomed hundreds of new families into Scouting, and the daughters of many existing Scout families. We now serve nearly 1,200 girls in our Cub Scout program, and have 31 new Scouts BSA all–girl Troops serving more than 300 young ladies. With dedicated Scouts and leaders, boys and girls units alike, our programs flourished in 2019 with strong totals in rank advancement, increased camp attendance at all levels, and 335 Scouts achieving the rank of Eagle. Our Scouts earned more than 13,000 merit badges including nearly 4,000 in STEM categories, up more than 600 from 2018.

All these favorable outcomes include continued growth serving our Scouts and communities. Our ScoutReach and after-school programs are valued and staged for long-term success, particularly thanks to our volunteers and great donor support. We are also grateful for business partners and sponsors who supported significant investments in our camp properties to meet the needs of all our Scouts and visitors. Details of these crucial camp improvements are highlighted in this annual report.

Thankfully, through a time of challenging but rewarding transition, Scouting is healthy and vibrant in Simon Kenton Council. Our success is only made possible thanks to you; our volunteers, donors and partners. We are Scouting forward... and it's more about fulfillment than change. Guided by timeless values, we are making a positive impact on the lives of youth along their journey through Scouting.



Greif, Inc. Grant Gives Inner City **Kids New Outdoor Opportunities**

Thanks to a generous grant from Greif, Inc., our community-focused program Project: Camp continues to provide an immersive day in nature at Camp Lazarus for the entire population of students from select inner-city schools. While at camp, students study natural sciences in our "Classroom in the Woods," join in teambuilding activities, and engage in hands-on STEM learning. While just a one day experience, the teachers and principals report that the effects are far reaching. It is a day filled with real moments of awe and wonder inspiring students who may have never experienced this much nature in their lives. Project: Camp is offered each spring and fall, serving two to three schools each season.

Scouts Across Our Council Helped Move Scouting Forward

Here are just a few highlights from this year's community outreach efforts.

Arrow of Light Scouts built wood duck boxes for Delaware Preservation Parks during day camp. The wooden structures allow hens to nest in relative safety from predators.

Scouts from Red Arrow Day Camp donated 180 containers of peanut butter and jelly to Athens County Job & Family Services during their annual PB&J drive, doubling last year's efforts!

November marked another successful Scouting for Food campaign, with Scouts throughout the Simon Kenton Council collecting non-perishable items for food pantries. Throughout our 19-county area Scouts collected thousands of pounds of food, making a difference in the lives of many families.

Sea Scouts placed wreaths on veterans' graves over the holiday season to remind families that their loved ones were remembered.

With the addition of young women to the Scouting program, much needed improvements were made to the shower facilities at Camp Falling Rock. Chief Logan Reservation and Camp Lazarus. Creating new shower spaces wasn't the only improvement made to our camps this year...

Camp Falling Rock

Camp Falling Rock has a new visitor center! Through a capital campaign spearheaded by Park National Bank and local community leaders, the Park National Bank Visitor Center opened June 2019. The Visitor Center is home to the trading post, camp master quarters and visitor restrooms. This addition is a welcomed improvement to the camp and offers our guests and campers an improved camping experience.

Camp Oyo

Wagner Lodge experienced major renovation in 2019. Through donations and the hard work of the Camp Oyo Alumni Association, Wagner Lodge has new mattresses, new lighting, new bunk beds and a new concrete floor. These welcomed additions help preserve this historic lodge, making it available for years to come.

Chief Logan Reservation

Through a round of donations and corporate matches totaling \$18,500, Mead Lodge, the iconic former dining hall, received a new roof! This longneeded improvement gave new life to the building, further extending its year-round usage. As the summer camp home for field sports and STEM lab, Mead Lodge will continue to serve vouth and adults.

In addition to the new roof CLR also updated the zipline, installed electric for the staff cabins, and added an additional staff cabin.

Camp Lazarus

Completion of the sewer connection for Camp Lazarus eliminated several capacity and environmental issues plaguing the camp for the last several decades. Replacing the oldest wastewater treatment facility in the state was a major improvement solving contamination issues for Lazarus Run and ultimately the Olentangy River.

February 2, 2019 launched a historic time in the Boy Scouts of America – young ladies were welcomed into our older youth program, Scouts BSA (formerly known as Boy Scouts).

To celebrate this exciting time, Simon Kenton Council hosted a launch party at Vertical Adventures in Columbus where more than 300 Scouts and their families spent the evening climbing, and our newest young ladies spent the night.

News outlets from Columbus came out and interviewed our Scouts, capturing their excitement of the occasion. When the common question was asked as to why they are joining the Boy Scouts of America, the responses included: "Because I want to be an Eagle Scout!" and "Because I want to be able to do all the things my brother gets to do!"

To date, SKC has 31 all-girl Troops serving more than 300 young ladies. At the Pack level, we are serving nearly 1,200 girls!
