



SCOUT REGISTRATION and/or UNIFORM SCHOLARSHIP INFORMATION

It's important to the Simon Kenton Council that no Scout ever be denied participation in the Scouting program due to his/her family's financial situation. Financial scholarships are provided to Scouts whose family is not able to cover the full amount of the BSA's national and Simon Kenton Council's registration fee or purchase a basic Scout uniform.

Where a family can contribute to the cost of their Scout's participation it is requested that they do so. Scholarship funds are otherwise provided on a sliding scale based on family size, income and/or hardship. The more detail provided on the scholarship form, the better the ability for the council to address the family's need.

What does the council cover with a registration scholarship?

- All or a portion of the National BSA fee
- All or a portion of the Simon Kenton Council registration fee

What does the council NOT cover with a registration scholarship?

- Unit dues/fees
- Activity or camp fees (camp scholarships may be provided via a separate request)
- Scouting Life magazine

What does the council cover with a uniform scholarship?

- Scout shirt
- Council shoulder patch, World Scout Crest and unit numerals
- Neckerchief and slide

What does the council NOT cover with a uniform scholarship?

- Belt, pants, socks

Form Instructions

1. Complete, sign and date the form.
2. Have a Unit Leader (Cubmaster, Scoutmaster, Crew Advisor, Committee Chair or Chartered Organization Representative) sign and date the form.
3. Submit the signed form to your District Executive/Director via email, fax (614-733-2557) or US mail to Simon Kenton Council, Attn: Scholarship Committee, 807 Kinnear Rd, Columbus OH 43212.
4. Request will be reviewed. The Parent/Guardian and Unit Leader will be notified within 30-days of receipt.
